## **WIN Energy REMC Scholarship Program**

A new scholarship program has been established for graduating seniors that meet the qualifications listed below. Scholarships will be awarded in increments of \$500. Applications must be submitted to the WIN Energy REMC office no later than 4:30 p.m. local time on March 1, 2012. Recipients will be recognized and awarded certificates at the WIN Energy REMC Annual Meeting in March. Scholarship funds will be dispersed upon proof of enrollment.

### **QUALIFICATIONS:**

- The parents/legal guardians of the applicant must be WIN Energy REMC members.
- Applicant must be a 2012 graduating senior and have maintained a cumulative grade point average of a C or higher. A copy of the high school transcript is required.
- Scholarship funds may be applied towards tuition or course fees at any recognized two-year or four-year college or trade school.
- Recipients must be enrolled as a full time student in the fall of 2012. Proof of enrollment must be presented to WIN Energy REMC before scholarship funds are dispersed.
- Full or part-time employees of WIN Energy REMC; or a spouse, son, daughter, stepson, stepdaughter, grandchild, brother, sister, aunt, uncle, niece or nephew of an employee or director of WIN Energy REMC are ineligible to apply.
